

Pursuant to article 42 paragraph 2 of the Law on financing of political entities and election campaigns (Official Gazette of Montenegro, 52/14), Agency for Prevention of Corruption hereby issues the

**INSTRUCTIONS
ON CONTENT OF THE REPORT ON CONTRIBUTIONS FROM LEGAL AND NATURAL
PERSONS TO POLITICAL ENTITIES IN THE COURSE OF ELECTION CAMPAIGN**

Article 1

These Instructions shall define the content of the report on contributions from legal and natural persons to political entities in the course of election campaign.

Article 2

Political entity shall submit the report on contributions from legal and natural persons to the Agency for Prevention of Corruption, using the forms that represent an integral part of these Instructions, in hardcopy and electronic form - directly or by post, every 15 days during the election campaign.

The term legal persons, in terms of these Instructions, shall be legal persons, business organizations and entrepreneurs.

Article 3

Data on political entity shall be provided on "PPS" Form - data on political entity. Data on contributions shall be provided on:

- "PPPL" Form - revenues from contributions from legal persons.
- "PPFL" Form - revenues from contributions from natural persons.

Article 4

With the entry into force of these Instructions, the Instructions on the content of reports on contributions from legal and natural persons to political parties in the course of election campaign, dated 26 April 2015 (Official Gazette of Montenegro, 14/15), shall cease to apply.

Article 5

These Instructions shall enter into force on the day of publication thereof in the Official Gazette of Montenegro.

Note: Contributions shall be payments that natural persons voluntarily make to political entity, in excess of the amount of membership fees, as well as provision of services or products without charge or under conditions where a political entity is put in a privileged position compared to other consumers, as well as borrowing from banks and other financial institutions and organizations under the terms different from the market ones, and partial debt write-offs (in accordance with article 6 of the Law).

Note: All information marked with the symbol “#” shall be excluded from publishing on the Agency's website. Such data shall be used for the purposes of supervision and control under the competence of the Agency.
