

Pursuant to Article 22 paragraph 5 of the Law on Prevention of Corruption (Official Gazette of Montenegro, 53/14), the Ministry of Justice hereby issues the

Rulebook **on the manner of keeping the register of sponsorships and donations and content of the report on received sponsorships and donations**

Rulebook is published in the Official Gazette of Montenegro, 75/15, dated 25 December 2015, and entered into force on 01 January 2016

Article 1

This Rulebook shall prescribe the manner of keeping the register of sponsorships and donations, as well as the content of the report on received sponsorships and donations, which state authority, state administration body, judicial body, local government authority, local administration body, independent body, regulatory body, public institution, public company or other business organization or legal person, exercising public authority, or activities in the public interest, or the state-owned legal person (hereinafter: public authority), submit to the Agency for Prevention of Corruption.

Article 2

The register of sponsorships and donations shall be an electronic database of sponsorships and donations, established based on the reports referred to in Article 1 of this Rulebook.

The data shall be entered into the register of sponsorships and donations in the order of receipt of the reports referred to in article 1 of this Rulebook.

The register of sponsorships and donations shall be kept for each calendar year separately, using the form that constitutes an integral part of this Rulebook.

Article 3

The report referred to in Article 1 of this Rulebook shall contain: data on responsible person in public authority, who signed a sponsorship/donation contract, (name and surname, place of residence or address), date of concluding sponsorship/donation contract, date of receipt of sponsorship/donation, data on sponsor/donor (name, surname and place of residence, or address of a natural person or name and seat of the legal legal person, tax identification number, name and surname of responsible person in the legal person, and place of residence or address), data on whether it is a donation or sponsorship, type and brief description of sponsorship or donation (money, goods or services), value of sponsorship or donation, in EUR, type of service to be provided in

case of sponsorship, data on decisions declared null and void in accordance with Article 22, paragraph 3 of the Law on Prevention of Corruption (reference number and date of the decision adopted under influence of received sponsorship or donation, brief description of the decision, reference number and date of the decision proclaiming null and void the decision adopted under the influence of the received sponsorship or donation, short description of the decision, reference number and date of the decision), place, date and signature of responsible person in the public authority.

Article 4

This Rulebook shall be published in the Official Gazette of Montenegro and shall enter into force on the date of entry into force of the Law on Prevention of Corruption.
