Pursuant to article 26 paragraph 4 of the Law on Prevention of Corruption (Official Gazette of Montenegro, 53/14), the Ministry of Justice hereby issues the

RULEBOOK ON THE CONTENT AND MANNER OF KEEPING THE REGISTER OF INCOME AND ASSETS OF PUBLIC OFFICIALS

The Rulebook was published in the Official Gazette of Montenegro, 77/15, dated 30 December 2015 and entered into force on 1 January 2016

Article 1

This Rulebook shall prescribe the manner of entering data from the report on income and assets of public official, as well as on income and assets of the spouse and children, if they live in the same household (hereinafter: the Report), into the Register of income and assets of public officials, and the content and manner of keeping the Register.

Article 2

The expressions used in this Rulebook to denote natural persons in the masculine gender shall also include the feminine gender.

Article 3

The Register of income and assets of public officials shall be an electronic database, established based on the data from the Report and shall include:

- 1) The purpose of reporting and the reporting period;
- 2) Personal data on public official and the members of shared household referred to in article 1 of this Rulebook, as follows: name and surname, personal identification number, place of permanent or temporary residence and address, education and occupation, and for the public official it shall also include father's name, mother' name, mother's maiden surname and contact telephone number;
- 3) Data on public office held, memberships in working bodies (working groups, commissions, councils, etc), and memberships in managing bodies and supervisory boards of public enterprises, public institutions and other legal persons, with the share of capital owned by the state or municipality, Royal Capital, or Administrative Capital, as well as in scientific, educational, cultural, artistic, humanitarian, sports or similar associations;
- 4) Data on income and assets of public official and members of the shared household referred to in article 1 of this Rulebook, as follows:
- ownership rights over immovable assets and rights of lease over immovable assets for a period longer than one year, in the country or abroad,
- ownership rights over movable assets, the value of which exceeds € 5,000, or which must be registered with the competent authorities (motor vehicles, vessels, aircrafts, etc);

- ownership rights over immovable and movable assets of a company, institution or other legal person, owned or established by the public official;
- deposits in banks and other financial institutions, in the country and abroad;
- stocks and shares in legal persons and other securities;
- cash in the amount exceeding € 5,000;
- rights arising from copyrights, patent and similar rights, intellectual and industrial property rights;
- debts (principal, interest and repayment schedule);
- receivables,
- income arising from exercising public function,
- income arising from memberships in working bodies (working groups, commissions, councils etc.),
- income, premiums and benefits from other job, activity, rent or other sources,
- sources and amount of income from performance of scientific, educational, cultural, artistic and sports activities,
- income of members of shared household.

The form of the Register of income and assets of public officials shall be an integral part of this Rulebook.

Article 4

This Rulebook shall be published in the Official Gazette of Montenegro and shall enter into force on 1 January 2016.
